


Board

- Represents HSPC/CIIC back to external community





Authoring and Sharing Knowledge Content

Ongoing Analysis and Adaptation of OMG/HL7 Business Knowledge Content Management Standards for Medicine.

Achievements

- BPM+ Community founded.
- BPM Field Guide, version 2 in Draft form.
- BPM Pregnancy Use Case Continued Maturation.
 - Use of BPMN to design the workflow
 - Design converted to applications and in use.
- Decision Model and Notation, version 1.2 available-First experience.
 - Mayo development of clinical applications.
 - Trisotech demonstrates >500 clinical calculators
- Maturation of ePulmonary Embolism BPMN Use Case using HSPC Sandbox/FHIR.
- HL7 CQL Release 1 STU4 (CQL 1.4).

Roadblocks

- First normative version of FHIR (version 4) requires transition from earlier versions.
- Full enterprise engagement in a Wide Range of Knowledge Modeling/Piloting initiatives.
- Useful extensions to OMG standards early in development.
 - Situational Data Model
 - Others
- Dependencies:
 - Agreed on profiles for FHIR Models for Data Reads/Writes, Orders, Decisions, Etc.
 - Availability of developers/knowledge engineers familiar with HL7/OMG standards.

Next Steps

- Continued development of BPM Field Guide, Release 2.
- Rapidly evolve HL7 CDS Hooks Standard.
- Test/Adopt Version 1.2 Decision Model and Notation
- ePulmonary Embolism Deployment planning.
- Additional Use Cases
 - From Pregnancy Management
 - Emergency Medicine
 - From other clinical guidelines
- Further exploration of Situational Data Model
 and Notation


